**RELEASE & INDEMNITY AGREEMENT -- READ CAREFULLY BEFORE SIGNING**

*I, the undersigned, and if I am a person under 18 years of age, my parents and I (hereafter "I") understand that this Event involves RISK OF SERIOUS PERSONAL INJURY, PROPERTY DAMAGE OR EVEN DEATH. The risks include but are not limited to NATURAL, MAN MADE, AND ENVIRONMENTAL CONDITIONS AND RISKS, including falls, changing weather and surface conditions, ski area equipment, variations in steepness or terrain, equipment failure, collisions with objects, structures, other people or equipment, negligence of others and exceeding my own abilities, which may cause severe or even fatal injuries.*

In consideration of participation in the Event and use of SNOWBASIN's facilities, I agree to the following:

1. I expressly agree to assume all risks of personal injury, falls, accidents, and/or property damage, **including those resulting from any negligence of Snowbasin Resort Company, its parent, subsidiary, brother, sister, closely related affiliate companies and all of their agents, officers, employees, property owners, and sponsors of the Event (hereinafter collectively "SNOWBASIN").**
2. **Release & Indemnity.** To the fullest extent allowed by law, I agree to forever release **SNOWBASIN** from any and all claims for injuries, losses, and damages resulting in any way from my attendance at the event, use of lifts or base lodges, my participation in this Event's training, practice, or competitions, including any negligence on the part of **SNOWBASIN**. My release includes all claims regarding the design, maintenance, manufacture, or conditions of Event site, course, structures or equipment utilized in the Event, express or implied warranties, product liability and the negligence of **SNOWBASIN**. To the fullest extent allowed by law, I agree to indemnify and hold **SNOWBASIN** harmless from all claims, damages or injuries in any way related to my participation in the Event, skiing/snowboarding, products liability or use of any facilities at **SNOWBASIN**, including breach of this Release, and will reimburse **SNOWBASIN's** attorney's fees and costs, even if **SNOWBASIN** was negligent.
3. I agree that no lawsuit will be filed by me or on my behalf against **SNOWBASIN** as a result of my participation in this Event or for any injuries or damages that I sustain even if **SNOWBASIN** was negligent. I understand that this is a contract, which limits my legal rights and is binding upon my heirs and my legal representatives. If portions of this Release are invalid, the remaining portions will remain intact and enforceable. Any lawsuits concerning my participation in the Event or this release must be brought in Utah's Third District Court, or Utah's Federal District Court. This Release shall be effective for all days of the Event.
4. I agree to conduct a careful inspection of any runs, course or facility used by me in the Event or training before any practice, training, or competition. I agree that I am solely responsible for my safety and responsible for utilizing and maintaining the equipment necessary for my participation. I agree to wear a helmet at all times during the EVENT and during any practice, training, or competition.
5. I shall accept and abide by the rules and regulations of this Event.
6. I irrevocably grant and agree that **SNOWBASIN** shall have the right to use, air, publish or reproduce photographs, video and/or pictures of my name, image and likeness for any lawful purpose.

I agree to ASSUME ANY AND ALL RISKS OF INJURY OR DEATH, which may be associated with or result in any way from my participation in any of the events or related activities. Further, I understand and agree that regardless of any employment relationship I may have with any participant or organizer of this event, I am not employed during the course of the event and no workers compensation coverage applies to the event.

I have *carefully read* this agreement. I understand this is a RELEASE OF LIABILITY, which legally PREVENTS me or any other person from filing suit or making any other legal claim in the event of my death or injury to me. I also understand my obligation to INDEMNIFY AND HOLD HARMLESS, even if an accident, damage, injury or death is sole or partial fault of Snowbasin. This agreement is binding upon my heirs, assignees and legal representatives. IF THE PARTICIPANT IS A MINOR (UNDER 18 YEARS OF AGE) THE PARTICIPANT AND THE PARENTS(S) MUST SIGN AND THE PARENTS(S) AGREE TO RELEASE AND INDEMNIFY SNOWBASIN ON BEHALF OF THE PARTICIPANT. I acknowledge that this event is taking place in the State of Utah and I further agree that only the laws of the State of Utah shall apply in construing or applying this Agreement.
